SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Carbon dioxide. Shutting off the source of the gas is the preferred method of control. Water spray or

fog. Be aware of the risk of formation of static electricity with the use of CO2 extinguishers. Do not

use them in places where a flammable atmosphere may be present.

Unsuitable extinguishing media : Do not use water jet to extinguish.

5.2. Special hazards arising from the substance or mixture

Reactivity in case of fire : No reactivity hazard other than the effects described in sub-sections below.

Specific hazards : Exposure to fire may cause containers to rupture/explode.

Escaping gas cannot be extinguished.

5.3. Advice for firefighters

7.1. Precautions for safe handling

A manually activated deluge water spray fire protection system shall be provided to protect bulk product delivery systems.

Safe handling of the gas receptacle

Protect containers from physical damage; do not drag, roll, slide or drop.

When moving cylinders, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport cylinders.

Leave valve protection caps in place until the container has been secured against either a wall or bench or placed in a container stand and is ready for use.

If user experiences any difficulty operating valve discontinue use and contact supplier.

Never attempt to repair or modify container valves or safety relief devices.

Damaged valves should be reported immediately to the supplier.

Keep container valve outlets clean and free from contaminants particularly oil and water. Replace valve outlet caps or plugs and container caps where supplied as soon as container is disconnected from equipment.
